# Section 1. Instructions to Tenderers

## A. General

1. Scope of Tender	<p>1.1 The Procuring Entity, as indicated in the Tender Data Sheet (TDS) issues this Tender Document for the procurement of non-Consulting Services as specified in the <b>TDS</b> and as detailed in <b>Appendix A</b> to the Contract. The name of the Tender and its number and identification is stated in the <b>TDS</b>.</p> <p>1.2 The successful Tenderer will be expected to complete the performance of the Services by the Intended Completion Date as stated in the <b>TDS</b>.</p>
2. Interpretation	<p>2.1 Throughout this Tender Document:</p> <ul style="list-style-type: none"><li>(a) the term “in writing” means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail;</li><li>(b) if the context so requires, singular means plural and vice versa;</li><li>(c) “day” means calendar days unless otherwise specified as working days;</li><li>(d) “Person” means and includes an individual, body of individuals, sole proprietorship, partnership, company, association or cooperative society that wishes to participate in Procurement proceedings;</li><li>(e) “Tenderer” means a Person who submits a Tender;</li><li>(f) “Tender Document” means the Document provided by a Procuring Entity to a Tenderer as a basis for preparation of the Tender; and</li><li>(g) “Tender” depending on the context, means a Tender submitted by a Tenderer for execution of Works and physical services to a Procuring Entity in response to an Invitation for Tender</li></ul>
3. Source of Fund	<p>3.1 The Procuring Entity has been allocated public funds as indicated in the <b>TDS</b> and intends to apply a portion of the funds to eligible payments under the Contract for which this Tender Document is issued.</p> <p>3.2 For the purpose of this provision, “public funds” means any monetary resources appropriated to the Procuring Entity under Government budget, or loan, grants and credits placed at the disposal of the Procuring Entity through the Government by the development partners or foreign states or organisations.</p> <p>3.3 Payments by the development partner, if so indicated in the TDS, will be made only at the request of the Government and upon approval by the development partner or foreign state or Organisation in accordance with the applicable Loan / Credit / Grant Agreement, and will be subject in all respects to the terms and conditions of that Agreement.</p>

<p>4. Corrupt, Fraudulent, Collusive or Coercive Practices</p>	<p>4.1 The Government requires that Procuring Entities, as well as the Tenderers shall, during the procurement proceedings and the execution of Contracts under public funds, ensure-</p> <ul style="list-style-type: none"> <li>a. strict compliance with the provisions of Section 64 of the Public Procurement Act 2006 including amendments thereto;</li> <li>b. abiding by the code of ethics as mentioned in the Rule 127 of the Public Procurement Rules, 2008 including amendments thereto;</li> <li>c. that neither it's any officer nor any staff or any other agents or intermediaries working on its behalf engages in any practice as detailed in the Rule 127.</li> </ul> <p>4.2 If corrupt, fraudulent, collusive or coercive practices of any kind is determined by the Procuring Entity against any Tenderer alleged to have carried out such practices, the Procuring Entity shall:</p> <ul style="list-style-type: none"> <li>a. exclude the concerned Tenderer from further participation in the particular procurement proceeding; or</li> <li>b. reject any recommendation for award that had been proposed for that concerned Tenderer; or</li> <li>c. declare, at its discretion, the concerned Tenderer to be ineligible to participate in further procurement proceedings, either indefinitely or for a specific period of time.</li> </ul>
<p>5. Eligible Tenderers</p>	<p>5.1 This Invitation for Tenders is open to all potential Tenderers.</p> <p>5.2 Tenderers shall have the legal capacity to enter into the Contract under the Applicable Law.</p> <p>5.3 Tenderers shall be enrolled in the relevant professional or trade organisations registered in Bangladesh.</p> <p>5.4 Tenderers may be a physical or juridical individual or body of individuals, or company invited to take part in public procurement or seeking to be so invited or submitting a Tender in response to an Invitation for Tenders.</p> <p>5.5 Tenderers shall have fulfilled its obligations to pay taxes under the provisions of laws and regulations of Bangladesh.</p> <p>5.6 Tenderers and all parties constituting the Tenderer shall not have a conflict of interest.</p> <p>5.7 Tenderer in its own name or its other names or also in the case of its Persons in different names, shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive or coercive practices as stated under ITT Clause 4.2.</p>
<p>6. Site Visit</p>	<p>6.1 Tenderers, at the Tenderers' own responsibility and risk, are encouraged to visit and examine the Site of required Services and its surroundings and, obtain all information that may be necessary for preparing the Tender and entering into a contract for the Services. The costs of visiting the Site shall be at the Tenderers' own expenses.</p>

7. Tender Document	<p>7.1 The Sections comprising the Tender Document are listed below, and should be read in conjunction with any Addendum issued under <b>ITT Clause 9</b>.</p> <ul style="list-style-type: none"> <li>a. Section 1 Instructions to Tenderers (ITT)</li> <li>b. Section 2 Tender Data Sheet (<b>TDS</b>)</li> <li>c. Section 3 General Conditions of Contract (GCC)</li> <li>d. Section 4 Particular Conditions of Contract (<b>PCC</b>)</li> <li>e. Section 5 Tender and Contract Forms</li> <li>f. Section 6 Activity Schedule/</li> <li>g. Section 7 Performance Specifications and Drawing</li> </ul>
8. Clarification of Tender Document	<p>8.1 A prospective Tenderer requiring any clarification of the Tender Document shall contact the Procuring Entity in writing at the Procuring Entity's address and, within time as specified in the <b>TDS</b>.</p>
9. Addendum to Tender Document	<p>9.1 At any time prior to the deadline for submission of Tenders, the Procuring Entity on its own initiative or in response to a clarification request in writing from a Tenderer, may revise the Tender Document by issuing an Addendum.</p> <p>9.2 <b>The Addendum issued under ITT Sub Clause 9.1 shall become an integral part of the Tender Document and shall have a date and an issue number and must be circulated by fax, mail or e-mail, to Tenderers who have purchased the Tender Documents, within five (5) working days of issuance of such Addendum, to enable Tenderers to take appropriate action.</b></p> <p>9.3 <b>If an Addendum is issued when time remaining is less than one-third of the time allowed for the preparation of Tenders, the Procuring Entity at its discretion shall extend the deadline by an appropriate number of days for the submission of Tenders, depending upon the nature of the Procurement requirement and the addendum. In any case, the minimum time for such extension shall not be less than three (3) working days.</b></p>
<b>C. Qualification Criteria</b>	
10. General Criteria	<p>10.1 Tenderers shall possess the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, managerial capability, specific experience, reputation, and the personnel, to perform the contract, which entails setting pass/fail criteria, which if not met by the Tenderers, will result in consideration of its Tender as non-responsive.</p> <p>10.2 In addition to meeting the eligibility criteria, as stated under ITT Clause 5, Tenderers must satisfy the other criteria stated in ITT Clauses <b>10 to 16</b> inclusive.</p>

11. Experience Criteria	<p>11.1 Tenderers shall have the following minimum level of experience to qualify for the performance of the non-Consultant Service under the Contract:</p> <ul style="list-style-type: none"> <li>a. a minimum number of years of general experience in contracting industries in public sector as Prime Contractor/Sub Contractor/Management Contractor as specified in the TDS;</li> <li>b. a minimum number of years of specific experience <b>(to comply with this requirement service contracts cited should be at least 70 percent complete)</b> as Prime Contractor in providing non-Consulting Service of a nature, complexity and methods/technology similar to the proposed non-Consulting Service in at least a number of contracts over the period, as specified in the TDS.</li> </ul>
12. Financial Criteria	<p>12.1 Tenderer shall have the following minimum level of financial capacity to qualify for the performance of the Services under the Contract.</p> <ul style="list-style-type: none"> <li>(a) the average annual turnover as specified in the TDS during the period specified in the TDS;</li> <li>(b) availability of minimum liquid assets i.e. working capital or credit line(s) from any scheduled Bank of Bangladesh, net of other contractual commitments, of the amount as specified in the TDS.</li> </ul>
13. Personnel Capacity	<p>13.1 Tenderers shall have the minimum level of personnel capacity to qualify for the performance of the Services under the Contract consisting of key personnel with qualifications and experience as specified in the TDS.</p>
14. Equipment Capacity	<p>14.1 Tenderers shall own suitable equipment and other physical facilities or have proven access through contractual arrangement to hire or lease such equipment or facilities for the desired period, where necessary or have assured access through lease, hire, or other such method, of the essential equipment, in full working order, as specified in the TDS.</p>
15. Joint Venture	<p>15.1 No Joint Venture (JV) shall be permissible under this Invitation for Tenders. Tenders submitted in the form of JV shall be considered non-responsive.</p>
16. Sub-contractor	<p>16.1 The successful Tenderer shall under no circumstances assign the services or any part of it to the Subcontractor(s).</p>
<b>D. Tender Preparation</b>	
17. Only One Tender	<p>17.1 Tenderers shall submit only one (1) Tender for each package. Tenderer who submits or participates in more than one (1) Tender in one (1) package will cause all the Tenders of that particular Tenderer to be considered non-responsive.</p>



18. Cost of Tendering	<p>18.1 Tenderers shall bear all costs associated with the preparation and submission of its Tender, and the Procuring Entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Tendering process.</p> <p>18.2 The Procuring Entity shall make Tender Documents available immediately to the potential Tenderers, requesting and willing to purchase at the corresponding price by the date the advertisement has been published in the newspaper.</p>
19. Language of Tender	19.1 The Tender shall be written in the English language. Correspondences and documents relating to the Tender may be written in English or Bangla.
20. Contents of Tender	<p>20.1 The Tender prepared by the Tenderer shall comprise the following:</p> <ol style="list-style-type: none"> <li>a. Tender Submission Letter (<b>Form PSN-1</b>) as stated under ITT Sub Clause 21.1;</li> <li>b. Tenderer Information (<b>Form PSN-2</b>) as furnished in Section 5: Tender Forms;</li> <li>c. the Priced Activity Schedule as stated under ITT Sub Clause 21,22 and 23;</li> <li>d. the Tender Security as stated under ITT Clauses 26 and 27.</li> <li>e. the written confirmation authorizing the signatory of the Tender to commit the Tenderer, as stated under ITT Sub Clause 30.2;</li> <li>f. the Valid Trade License;</li> <li>g. documentary evidence of Tax Identification Number(TIN) and VAT as a proof of fulfilment of taxation obligations as stated under ITT Sub Clause 5.5;</li> <li>h. documentary evidence as stated under ITT Clause 24 establishing the Tenderer's eligibility and minimum qualifications required to be met for due performance of the physical services under the Contract; and</li> <li>i. Curriculum vita of proposed manpower in case of outsourcing manpower.</li> <li>j. for physical service, along with academic &amp; experience certificate in case of supply of man-power (out-sourcing) as <b>stated in section 6: Activity schedule.</b></li> <li>k. any other document as specified in the <b>TDS.</b></li> </ol>
21. Tender Submission Letter and Priced Activity Schedule	<p>21.1 Tenderers shall submit the Tender Submission Letter (<b>Form PSN-1</b>), which shall be completed without any alterations to its format, filling in all blank spaces with the information requested, failing which the Tender may be considered non-responsive as being incomplete.</p> <p>21.2 Tenderers shall submit the priced Activity Schedule using the form(s) furnished in Section 6: Priced Activity Schedule.</p> <p>21.3 If in preparing its Tender, the Tenderer has made errors in the unit</p>

	rate or price or the total price, and wishes to correct such errors prior to submission of its Tender, it may do so, but shall ensure that each correction is initialled by the authorised person of the Tenderer.
22. Tender Prices	22.1 The Contract shall be for the Services, as described in <b>Appendix A</b> to the contract and in <b>Section 7: Performance Specifications and Drawing</b> , based on the priced <b>Activity Schedule</b> , submitted by the Tenderer.
	22.2 The Tenderer shall fill in rates or prices inclusive of profit, overhead, Applicable Tax & VAT for all items of the Services described in the <b>Specifications</b> and listed in the <b>Activity Schedule</b> .
	22.3 The items quantified in the priced <b>Activity Schedule</b> for which no unit rates or prices have been entered by the Tenderer will not be paid for by the Employer when executed and shall be deemed covered by the other rates and prices in the <b>Section 6: Activity Schedule</b> .
	22.4 All kinds of applicable taxes ,customs duties, fees, levies, VAT and other charges payable by the Service Provider under the Contract, or for any other cause, as of the <b>date twenty-eight (28) days prior to the deadline for submission of Tenders</b> , shall be included in the <b>unit rates or prices and, the total Tender price submitted by the Tenderer</b> .
	22.5 The price of a Contract shall be fixed in which case the unit rates or prices may not be modified in response to changes in economic or commercial conditions.
	22.6 In case of manpower supply, the remuneration of manpower shall be fixed as consolidated payment as per government circular plus applicable Tax & VAT. Tender shall quote only the commission as stated in <b>section 6: Activity schedule</b> .
	22.7 Tenderer’s quoting rate of service commission of the Tender <b>less</b> the specific threshold specified in <b>TDS &amp; Section 6: Activity schedule</b> of the Tender Document as stated under ITT Sub 22.6, <b>shall be rejected</b> .
23. Tender Currency	23.1 Tenderers shall quote all prices in Bangladesh Taka (BDT) in the Tender Submission Letter and in the <b>Activity Schedule</b> .
24. Documents Establishing Eligibility and Qualification of the Tenderer	24.1 Tenderers shall complete and submit the documentary evidence, as applicable to satisfy the following: <ul style="list-style-type: none"> <li>(a) complete the eligibility declarations in the Tender Submission Letter (<b>Form PSN-1</b>);</li> <li>(b) complete the Tenderer Information (<b>Form PSN-2</b>);</li> <li>(c) general experience in service providing as stated under ITT Sub Clause 11.1(a), substantiated by the year of registration/constitution/licensing in its country of origin;</li> <li>(d) specific experience in service providing under public sector of similar nature and size as stated ITT Sub Clause 11.1(b), substantiated by Completion Certificate (s) issued by the</li> </ul>

	<p>relevant Procuring Entity(s);</p> <p>(e) average annual turnover i.e. total certified payments received for contracts in progress or completed under public sector for a period as stated under ITT Sub Clause 12.1(a), substantiated by Statement(s) of Receipts, from any scheduled Bank of Bangladesh, issued not earlier than twenty eight (28) days prior to the day of the original deadline for submission of Tenders;</p> <p>(f) adequacy of minimum liquid assets i.e. working capital substantiated by Audit Reports mentioned in (j) below or credit line(s), substantiated by any scheduled Bank of Bangladesh in the format as specified (<b>Form PSN-5</b>), without alteration, issued not earlier than twenty eight (28) days prior to the day of the original deadline for submission of Tenders for this Contract as stated under ITT Sub Clause 12.1(b);</p> <p>(g) key personnel along with their qualification and experience proposed for the Contract as stated under ITT Clause 13.1;</p> <p>(h) major items of service equipment proposed to carry out the Contract as stated under ITT Clause 14.1, substantiated by statement(s) in its letter-head pad declaring source of its availability;</p> <p>(i) authority (s) to seek references from the Tenderer's Bankers or any other sources in its letter-head pad;</p> <p>(j) reports on the financial standing of the Tenderer, such as profit and loss statements and audited balance sheet for the past years as specified in the <b>TDS</b>, substantiated by Audit Reports.</p>

25. Validity Period of Tender	<p>25.1 Tenders shall remain valid for the period specified in the <b>TDS</b> after the date of Tender submission deadline prescribed by the Procuring Entity. A Tender valid for a period shorter than that specified shall be considered as non-responsive.</p> <p>25.2 In exceptional circumstances, prior to the expiration of the Tender Validity period, the Procuring Entity may solicit all the Tenderers' consent to an extension of the period of validity of their Tenders; provided that those Tenderers have passed the preliminary examination as stated under ITT Sub Clause 39.2.</p> <p>25.3 The request and the responses shall be made in writing. Validity of the Tender Security provided under ITT Clause 25.2 shall also be suitably extended for twenty eight (28) days beyond the new date for the expiry of the Tender Validity. If a Tenderer does not respond or refuses the request it shall not forfeit its Tender Security, but its Tender shall no longer be considered in the evaluation proceedings. 28. ## Section 7. Performance Specifications and Drawings

### 'Hiring vehicle for SICIP-KWT Office'

**02 (Two) microbus Toyota X-NOAH/Similar Standard - (7-9) seat along with LPG and Octane provision (model shall be not older than 2018)**

#### Detailed definition of Services

The Service provider shall provide the services with the vehicles having following specification:

1. The vehicle model shall be not older than 2018.
2. The body of the vehicle shall be so well printed and dented that it looks like new with acceptable aesthetic view.
3. The seats and the seat-cover shall look good, neat and clean and free from aesthetic problem as per passengers' satisfaction.
4. The vehicle shall have all built-in-facilities including Air Conditioning.
5. The meter of the vehicle shall be operative for reading meter.

#### Detailed Days and Times

1. The service provider shall provide the service for maximum 26 days a month.
2. The service level shall be uninterrupted except force majeure situations.

#### Daily Activities:

1. The service provider shall provide the service for a period of approximately 12 (twelve) hours in a day. After 12 (twelve) hours duty in a day the overtime for the driver shall be applicable and the overtime rate would be tk. 50 (fifty) per hour.
2. Estimated running of the vehicles per day will be 40 Km to 50 Km.
3. The driver, along with the vehicle shall reach the defined place(s) as per specific schedule provided by the employer.
4. The driver shall maintain a logbook at his/her own responsibility and shall make it updated.
5. The driver shall commence his/her duty from such a time as required to reach the officials at the office as per specific schedule provided by the employer.
6. The driver shall not drive the vehicle recklessly but with safety following the traffic rules.

#### Specific Activities:

1. The service provider shall be responsible for the cost of driver, fuel, repair, maintenance, cleanliness, servicing, insurance etc. for the hired vehicle.
2. The service provider shall be responsible for the garage required for the vehicle.
3. As per requirement of the employer the service provider shall be bound to provide services to any place of Bangladesh any time without showing any excuse unless there is any force majeure situation.
3. Without valid reason acceptable to the employer, if the service provider fails to comply the request in serial 3 above, the penalty shall be imposed proportionate to the monthly rent for the non-compliance with the request by the employer. The valid reason will be determined by the employer and that shall be the final.
4. If any time the vehicles become out of order, the Service Provider shall instantly arrange an alternative vehicle of equivalent standard and facilities.

5. If because of illness or any other reason, the assigned driver fails to drive the hired vehicle, the Service Provider shall arrange an alternative driver that holds the valid driving license.
6. For all time communication with the driver, the Service Provider shall supply a cell phone to the assigned drivers at their cost.
7. The Service Provider shall not engage the hired vehicle along with the drivers for any other purpose within the period contracted for providing the Services.
8. The Service Provider shall be bound to change any driver any time depending upon the feedback from the user(s).

### **Tax Token, Road Tax, Fitness Certificate:**

Service Provider will be responsible for updating vehicle registration, road tax, tax token, fitness certificate, or any other legal documents as required by the Bangladesh Road Transport Authority or local representative of BRTA.

Vehicle provided by the Service Provider must carry the following documents:

- 1) Registration Certificate of the Vehicle
- 2) Valid Fitness Certificate
- 3) Tax Token
- 4) Valid Driver's License

All legal compliances in accordance of Law of Bangladesh to operate vehicle on the road must be followed. All legal paper of the supplied vehicle must be up-to-date as required by the local traffic rules and regulations, and a copy of these documents will be kept by the Program. The Service Provider will be responsible for paying all penalty or fines if imposed by any authority on any of the supplied vehicle or on any driver of the vehicle for violation of any rules or regulation of Bangladesh.

### **Maintenance:**

The Service Provider will arrange regular servicing and maintenance of the vehicle with prior consent by the Program management for smooth operation. Any maintenance, repairing and cleaning work should be done during the weekends upon mutual agreement between both the parties. The Service Provider will also be responsible for temporary replacement of the vehicle if there is maintenance work. The Service Provider will be responsible for replacement of all parts and equipment, including but not limited to tires, battery or any other parts of the vehicle required maintaining suitable operation of the vehicle. In case of unsatisfactory service or unsatisfactory performance of supplied vehicle, the Service Provider will be responsible for replacing the vehicle immediately.

### **Driver:**

- a) Driver's Daily allowance and distance driving allowance (outstation charge) will be directly paid by Service Provider.
- b) Drivers' Qualification:
  - i As per Tender Data Sheet.
- c) Assigned drivers shall be nominated in writing by the Service Provider and approved by Program, and the Service Provider will replace the driver at any time if not judged suitable by Program.
- d) The Service Provider will be fully responsible for all drivers' contractual obligations, including salaries, benefits and bonuses and other facilities.

### **VAT & TAX:**

VAT & AIT (Advance Income Tax) shall be deducted at Source as per GoB rules.

**Payment's procedure:**

The successful service provider will be required to submit invoices immediately after completion of each month services. Payment will be made in favor of the Service Provider within 10 (ten) working days upon satisfactory of services received and submission of correct invoice along with necessary documents.

Under no circumstances Program will not entertain any request for cash payment or partial payment for the invoice. Wherever applicable, tax as prescribed by Taxation Authority, will be deducted from the invoice.

**Termination:**

The Program reserves the right to terminate the contract at any time for any reason whatsoever by giving the successful service provider one month notice in writing. If the successful service provider wishes to terminate the contract, then they are to provide one month notice in advance to Program. The Program decision is final in case of any dispute that arises in connection with these termination arrangements.

For any Fraud case/Terrorism found or breach of contract, Program will terminate the contract/Agreement within 7 days' Notice to the service provider and Outstanding payment will be settle within next 15 (fifteen) working days subject to the submit all the relevant documents.

**Emergency Supports:**

Service Provider must provide the emergency support in Weekend, Govt. Holiday, Public Holiday and out of office hours etc. if required. If the vehicle runs more than 26 days in a month, then the rent for additional days will be paid by calculating from the monthly fixed rent of the vehicle.
